

## **EX-PAT CRITERIA &**DOCUMENT CHECKLIST

## Criteria



Retired and self-employed applicants accepted



Applicants must have an active credit footprint in the UK for the last 3 years



Applicants must be employed by a Multi-National Company or an acceptable Sovereign Entity



We require £25k minimum income and 3 months payslips for each applicant



Retired and employed applicants must have at least one BTL in the UK



Self-employed applicants must have at least two BTL in th UK



Ex-pat applicants must be residing in countries within the European Economic Area (EEA) and Financial Action Task Force (FATF) countries





We will require a letter from the employers on their headed paper confirming the applicants residential address in their country of employment and period of residency



We may require proof of address for each applicant's foreign residency, dated within the past 6 months



Ex-pat applicants must have a valid UK passport, which they can now conveniently certify online using the LexisNexis IDU mobile app



For personally owned properties, we will require up to 2 years SA100, SA302 and Tax Year Overview



If the properties are owned through a Limited Company, we will require up to two years full accounts



Where any of the applicants have four or more mortgaged BTL properties then property portfolio details will be required
